Our history to date:

In April 2016, a group of Sydney based insolvency proprietors came together and organised a monthly discussion group. There has been and there remains a large burden on small firms to meet compliance requirements to remain in business. It was also acknowledged that there was a need for a forum of likeminded practitioners where insights and frustrations could be shared, as well as earning inexpensive continuing education units.

'The Melbourne Forum' has been doing this for Victorian based insolvency practitioners for tens of years.

On 15 December 2016, our AIIP association was registered. It is now able and willing to reach out to all insolvency practitioners running small firms (less than 2/3 partners) across Australia to invite them to become a member.

Membership now open

The annual fee is \$20 for the calendar year.

Membership is restricted to only Registered Liquidators and Registered Trustees in Bankruptcy.

Application forms are included in this email – discussion groups are also open to senior staff.

The membership fees cover the cost of registering AIIP as an organisation, registering a domain name, creating a logo, developing the website and many other costs.

Our first collective project

We want to be compliant ready for the big changes on their way. By our collective effort, we could achieve the necessary compliance manuals, checklists and precedents in time and depending how many firms are interested at a very small fraction of the cost.
