Use of this form	<p>The use of this form is optional. It has been prepared by ASIC to assist business with the lodgement process by highlighting information required by ASIC.</p> <p>A Form 5053 is only required where the ending of the administration is not as a result of, or does not result in, another form of external administration. For example a Form 5053 is not required where a company is transitioning to a deed of company arrangement or a creditors' voluntary winding up. The Form 5053 removes the company from voluntary administration and the company reverts to registered status.</p>		
Lodgement period	<p>As soon as practicable.</p>		
How to provide additional information	<p>Annexures</p> <p>If there is insufficient space in any section of the form, you may alternately submit annexures as part of this lodgement.</p> <p>To make any annexure conform to the regulations, you must</p> <ol style="list-style-type: none">1. use A4 size paper of white or light pastel colour with a margin of at least 10mm on all sides2. show the company name and ACN or ARBN3. number the pages consecutively4. print or type in BLOCK letters in dark blue or black ink so that the document is clearly legible when photocopied5. mark the annexure with an identifying letter or symbol eg a,b,c or 1,2,3 etc.6. endorse the annexure with the words: This annexure (mark) of (number) pages referred to in form (form number and title)7. sign and date the annexure <p>The annexure must be signed by the same person(s) who signed the form.</p>
